

How it works

To obtain the Award, the National Autistic Society will take your organisation through a series of steps, covering key areas including:



Each section is broken down into overall goals to achieve and a series of tasks for you to complete. These will help you identify actions you are already taking or could take to make your business or service more autism-friendly. You are not expected to do everything and not everything will be relevant for your organisation. However, our Award framework will help you analyse what may be missing and what improvements are needed to make your business more autism-friendly.

Once you can provide evidence that you have met the criteria in these areas, your organisation will be issued with a certificate of accreditation

Training options


When completing the Award, you may find that there are particular areas that your organisation may need training and development on. The National Autistic Society's training can help you upskill your organisation through our Understanding autism training module.

Our online training modules are based on over 50 years of collaboratively supporting organisations to develop their autism practice.

For organisations with their own online learning platform, the National Autistic Society provides licences to host on your learning system for unlimited access for your staff. These licences are usually valid for 12 or 24 months.
